

INTERNATIONAL RESEARCH CONFERENCE OF NATIONAL LIBRARY OF SRI LANKA - ICNATLIB 2024 Author Guidelines for Submission of Extended Abstracts

Extended Abstract should be prepared appropriately and submitted electronically (MS word) and comply with the following specific guidelines will only qualify for the review process.

- **Length of the article** The length of the abstract should be 250-300 words and the Extended abstract should be limited to 1,200-1,500 word count including the abstract.
- **Font** Abstract should be in English (Times New Roman) / Extended Abstract can be written in English (Times New Roman), Sinhala (FMAbhaya) & Tamil (Kalaham) fonts.
- **Authors information** Author(s) name, affiliation(s), and email address(s) of the corresponding author need to be included. Name(s) of the author(s): Name of authors with initials are required. Affiliation of the author(s); For all authors, address(s) of the affiliated institute(s) and email addresses of each author are essentials.
- **Page limit** Maximum 3-4 pages including all figures, tables, and References.
- **The body of the papers** Should include an Abstract with Keywords and Introduction, Objectives, Methodology, Results, Discussion/Conclusion, and Recommendations with related References
- **Subheadings** Should be bold (12pt) and placed at the left-hand margin
- **Tables & figures** Tables must be prepared using standard formats and all tables must be uniform in format and font. All the tables, images, and figures should be centered. Figures and images should be numbered and figure legends should be placed under the figure or image; as for the tables, they should also be numbered and the table header should be placed at the top. If the data were extracted from other sources, please denote the source courtesy below the table. Figures should be clear and in black & white. Tables and figures should be set in line with the text.
- **Page numbers** Bottom & centered in right side
- **Footnotes** Avoid footnotes
- **Referencing style** Limit to 4-6 key references and follow the APA 7th edition
- **File Format** MS Word, name the attachment, “Last name of the first author _ICNATLIB 2024-001” (Your paper ID)

Abstract

Here write the abstract 250 – 300 words in English. (TNR 12pt)

Abstract should outline the purpose of the article, method of the research, data and main results

Keywords:(4-6 keywords in English)

Introduction - The introduction of your paper should state the nature of the research gaps you are addressing and why you are studying it. It should provide background information about the work and its significance while highlighting other relevant literature and specifying how it relates to or differs from your work. You should also discuss the scope and limitations of your study in the introduction.

Objectives - Objectives of the study should be clearly defined

Methodology - Provide a full description of your general research design, as well as the specific methods and procedures used in your research study. Describe your theoretical approach or type of analysis, and discuss the types of sources (primary or secondary texts, interviews, surveys, personal notes, etc.) and analysis tools (including statistical method/s) used.

Results – Describe the results in a logical framework providing diagrams, charts, and illustrations as appropriate for your discipline.

Tables & Figures: Tables & figures must be created using the Microsoft Word or Word Perfect table functions and included as part of the text immediately after the first point of reference. **DO NOT** place them at the end of your extended abstract. For improved readability, keep your tables as simple as possible.

All the tables, images and figures should be centered. Figures and images should be numbered and figure legends should be placed under the figure or image; as for the tables, they should also be numbered and the table header should be placed at the top. If the data were extracted from other sources please denote the source courtesy immediately below the table.

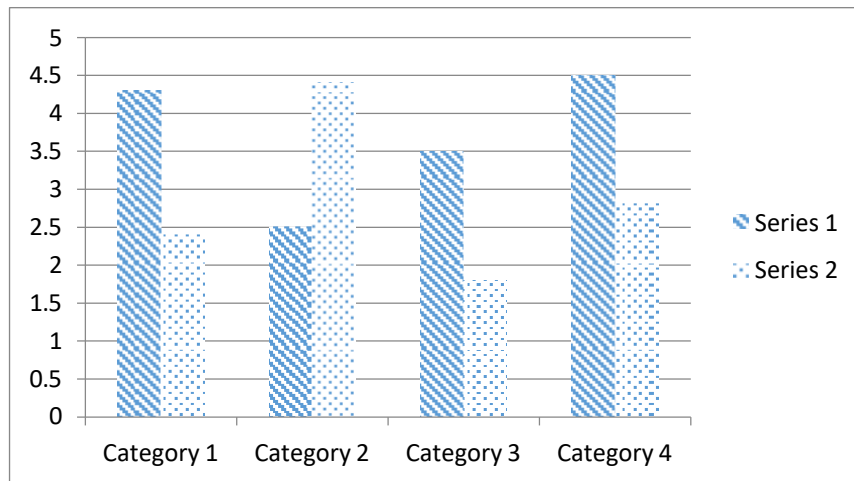
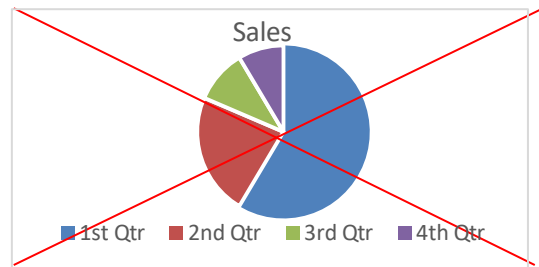
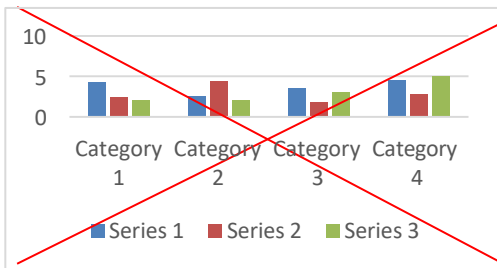


Figure 2 : Preferences of students on different modes of obtaining reading materials

Discussion - The purpose of the discussion is to interpret and describe the significance of your findings in light of what was already known about the research problem being investigated, and to explain any new understanding or fresh insights about the problem after you've taken the findings into consideration.

Conclusion - The conclusion is intended to help the reader understand why your research should matter to them and provide a synthesis of arguments presented in the paper to show how these converge to address the research problem and the overall objectives of your study. Also state your conclusions in clear, simple language.

References - References should be cited within your extended abstract using APA (American Psychological Association) style. Examples of reference formats are given here. For additional information on formatting references, refer to the 7th edition of the publication manual of the American Psychological Association.
